- Content : Usage of Flag Signal; Driving Etiquette; Structure of the Kart; Educate the rolling start for karting race. The course will conduct Theory, Practical and Driving Assessments.

1. Course will be present in Cantonese.
 2. The Transportation for Futian Port, Shenzhen is on your own. Please bring along your belongings (e.g. RMB, towels, water, clothing etc.).
 3. Each *accompanied person** will be charged an additional fee (HKD250) as the transportation from Futian Port, Shenzhen to Karting Track (Round Trip).
**For participant who is under 18 : If there are accompanied persons, at least ONE of them must be aged 18 or above.*
 4. Please make sure your Mainland Travel Permit for Hong Kong and Macau Residents is valid.
 5. It is recommended that participants who have a basic understanding of kart and driving experience to enrol.
- Others : Karting Practice License will be issued to qualified candidates (for passing theory and practical assessments);
You may apply for National Karting Competition License after the satisfactory of driving assessment. (Required to register as the Ordinary Member and fulfil other application requirement.)

Terms and conditions :

1. Applicants must make sure that he/she is physically fit and suitable to participate in such course, ensure the information filled in the application is true and correct.
2. Applicant who is under 18 must be consulted and with consent from Parent or Legal Guardian before the application.
3. **Once the application has been accepted, applicants will not be allowed to change his/her entry to another person or to have any of his/her entry fee refunded. Unless the course cancelled or revised, all the payment will not be refunded.**
4. Applicants should arrange the necessary insurance according to the needs, such as accidental injury and death insurance and property protection insurance.
5. Applicants must follow all instructions of the Course-in-charge or officials during the course and must notify them in case of sickness.
6. Course-in-charges or officials have the rights to refuse the applicants to continue participating in the course due to lack of discipline or any other reasons, all the payment will not be refunded.
7. Applicants agree to pay for any collusion, damage to respective property, facilities, and equipment.
8. Karting Association of Hong Kong, China has the rights to accept and reject any application without any explanations.
9. Applicants shall take responsibility for their own belongings. The Association shall not be liable for any loss or damage. It is highly recommended that not to bring the valuables attending the course.
10. The event will be cancelled if Typhoon Signal no.8 or above is hoisted and/or Red Rainstorm Warning Signal is issued. The reschedule class will be announced later.
11. Course-in-charge shall decide whether to continue at the latest two hours before the assembly time according to the actual weather conditions. Course will be normal if there is no announcement.
12. Applicants agree that photographs may be taken during the course and those photographs may be used by the Association on public (include but not limited to poster, website, social media platform etc).
13. Due to the costing, the Course will be cancelled if there are not enough applicants.
